New NSF Biosketch Requirements Mandatory as of January 2020

The National Science Foundation (NSF) has designated the National Institutes of Health's <u>SciENcv</u> (Science Experts Network Curriculum Vitae) as an NSF-approved format for submission of biographical sketch(es) and is encouraging its use to prepare a biographical sketch for inclusion in proposals to NSF.

Beginning with the next iteration of the *Proposal & Award Policies & Procedures Guide* (PAPPG) (anticipated effective date, January 2020), NSF will only accept PDFs for biographical sketches that are generated through use of an NSF-approved format.

Important Requirements for Completing Current and Pending Support Documents

It is the Principal Investigator's responsibility to comply with all PSU and sponsor regulations and guidelines in the grant proposal and in the management of grant awards.

Both the NIH and the NSF have clarified their expectations for disclosure of "Other Support". Researchers are expected to disclose all resources made available to a researcher in support of and/or related to all of their research endeavors, regardless of whether or not they have monetary value and regardless of whether they are based at Penn State or received external to Penn State. They interpret Other Support to include the following:

- Paid appointments at another university
- Unpaid appointments at another university involving access to lab space, research materials, and/or research personnel
- Research collaborations at another university that directly benefit the investigator's research endeavors
- Research performed outside of a faculty member's appointment (e.g., a faculty member with a 9-month appointment at Penn State and a two-month appointment at another university performed during the summer)
- Outside Activities such as teaching or consulting (compensated or uncompensated) if they are in any way related to the investigator's research endeavors or expertise

NIH researchers are also expected to disclose start-up packages and internal to PSU institutional research grants in their Other Support forms.

<u>Foreign Collaborations</u>: Relationships with foreign collaborators must be disclosed in grant proposal documents. You must disclose whenever a significant part of the proposed research will be performed outside of the U.S. - regardless of who will be performing the research or funding the research. This information is to be included in grant proposals and progress/technical reports submitted to the sponsor according to sponsor instructions.

When performed outside of the U.S., the following activities would constitute a foreign collaboration that must be disclosed:

- Research involving human subjects or animals;
- Extensive travel for the purpose of data collection, surveying, sampling, and similar activities (excluding foreign travel for consulting);
- Collaborations with investigators anticipated to result in co-authorship;

- Use of facilities or instrumentation;
- Receipt of financial support or resources from a foreign entity;
- Any activity that may impact U.S. foreign policy through involvement in the affairs or environment of a foreign country.

NIH Requires new ORCID ID

The <u>NIH</u> and several academic journals across disciplines, require an ORCID ID when submitting certain proposals or papers. We expect that most funding and publishing organizations will require ORCID IDs. Therefore, Penn State is asking all researchers to adopt an ORCID ID through the process below.

- 1. Visit https://orcid.identity.psu.edu/
 - a. If you already have an ORCID, you will be asked to log in and link your ID to your Penn State ID.
 - b. If you do not have an ORCID, you will be prompted to create one, which you can then link to your Penn State ID.

Your ORCID is permanent and travels with you, even if you leave Penn State. Complete instructions or additional help is provided by the University Libraries at http://orcid.psu.edu
