

THE RESPIRATOR FIT TEST



Enclosed cabs

- We have lost the exemption for enclosed cabs regarding the wearing of a respirator – except for the TC – 84A (dust mask or particulate filtering).
- However – the TC – 84A must be fit tested.
- We **STILL** have the exemption for the clothing.

Handlers working with pesticides requiring a respirator must:

- first get a medical evaluation
- second, do the annual fit test
- third – be given respirator training



Alternate Options

- Switch to a pesticide that does not require respirators
- Use a loose fitting Powered Air Purifying Respirator (does NOT exempt Handler from the medical evaluation)
- Cabs with a positive pressure carbon filter No longer exempts the Handler from the need to wear a respirator

The Medical Evaluation

- Is NOT a physical but might lead to a physical if there are red flags
- The evaluation might be a once & done deal – open ended
- The evaluation might need to be repeated every year, 2 years, 3 years...



Medical Evaluation Providers

- Online providers – quick & easy & probably cheapest.
- If you have “red flag issues” you’ll probably end up going for a physical
- Contractors offer in office evaluations & some do it by mail.
- Can be done by any licensed health care provider



Documentation

- Maintain medical evaluation documentation at least two years
- Handlers with open ended medical evaluations need to keep them longer



Actual Fit Test

- Can be done by a contractor
- Some local fire companies will do these for a small donation.
- Can be done in house with a fit test kit.

Cheaper in costs and time

Kits come with directions that must be followed



The Test

- Use your regular respirator
- If you use different respirators test all of them
- Put the respirator on & first do a seal check, then do the actual test.
- Follow the directions!
- If the test cannot be passed it is time to get a new or different respirator
- Document! Keep test documentation at least two years!



Respirator Training for Employee Handlers

- How to clean the respirator
- How often to change out filters & cartridges
- Doing the seal check – EACH time you use it!
- Document training & keep on file at least two years



Coming up later this year

- EPA has announced that sometime later this year that they will open up a comment period on 3 areas:
 - the application exclusion zone (AEZ)
 - the designated representative
 - ages
