Penn State's Risk Management Office has provided us insights about the risk and liability that may occur when subcontractors come into our facility to provide services for your exhibits. They have identified a new protocol for your benefit in attending the 2025 PA Timber Show, to be held June 6 & 7, 2025 Please review the following requirements and have your service providers submit this information so that they may be placed on the Accepted Subcontractor List for our shows at Penn State. #### INSURANCE REQUIREMENT (ATTACH the COI)

The Certificate of Insurance (COI) must be issued in the name above, and meets the following:

1. The Certificate Holder must be shown as: **The Pennsylvania State University

University Park, PA 16802**
2. The Certificate of Insurance must evidence not less than \$1,000,000 per occurrence of both General Liability and Products Liability Insurances, written on an occurrence basis, including contractual liability.
3. The Pennsylvania State University must be shown as an Additional Insured on the General Liability Insurance.
4. The Certificate of Insurance must evidence not less than \$1,000,000 per occurrence of Automobile Liability Insurance.
5. Statutory Workers' Compensation Insurance must be evidenced. If you are not required to carry workers' compensation, please submit a [WC Waiver Request](#) along with your certificate.

\*Any notice from the Insurance Company that the insured's insurance has been canceled for any reason will result in deletion from the listing. The Pennsylvania State University reserves the right at all times to accept or reject the insurance company(s) shown on the certificate and to delete any listed vendor at any time.
