Senate Stimulus Package: Highlights

- On Wednesday, the Senate unanimously passed (96-0) The Coronavirus Aid, Relief, and Economic Security (CARES) Act (S.3548), a more than \$2.2 trillion aid bill as part of the ongoing response to the coronavirus pandemic
 - The bill contains \$9.5 billion in emergency funding to aid producers impacted by the ongoing crisis – reserved for Specialty crop producers, Livestock producers (including dairy), and producers that supply local food systems (including farmers markets, restaurants, and schools)
 - The bill lacks specifics- we will need to watch during implementation
 - \$100,000,000 for a rural broadband reConnect pilot
 - \$15.8 billion for the Supplemental Nutrition Assistance Program to cover an expected jump in applications as more workers are laid off. BUT no wins for advocates: no 15 percent boost to households' SNAP benefits, no increase of the minimum payment.
 - Boosts funding for targeted emergency food assistance for tribal communities through the Food Distribution on Indian Reservations (FDPIR)

Next Steps

- The Bill has to be passed by the House
- More opportunities in the 4th package
- We need to watch the bill during implementation to make sure the 9.5 billion is distributed equitably

Other opportunities for federal action:

- Paid sick days for all workers
- Expanding funding for existing programs to better serve farmers' needs during the crisis (LAMP, Crop Insurance)
- Personal Protective Equipment (for healthcare providers but also for farmworkers), eliminate student loan debt, worker protections and the right to unionize for farmworkers
- Set asides in farm funding for "socially disadvantaged" producers?

State Policy in PA

- Essential services in PA include:
 - o farms,
 - greenhouses and vegetable plants,
 - o orchards,
 - pest management services,
 - feed mills and ag supply businesses, agricultural equipment sales and service, animal feed and supply distribution network,
 - veterinary services and supplies,
 - retailers to include grocery stores and farmers markets
- Some areas of PA have enacted stay-at-home orders, while other counties have not
- Penn State Extension will conduct on-farm visits, remote consultations, and has online resources available

Potential Policy Ideas from other States:

- Administrative flexibility for state grant or contract obligations
- Grants and cash support for emergency relief
- Expanded unemployment benefits to include entrepreneurs, small business owners, and all workers regardless of immigration status.
- No evictions from farms or food facilities, and no foreclosures or delinquency penalties on personal and business loans.
- Grocery store employees and other food chain workers can be classified as essential employees to qualify for free childcare
- Technical assistance for transitioning farmers to online sales

How to act?
